- Rolling **Implementation** (Mid-2025 Onward): Other Accountable Bodies will phase in their delivery; however, starting the software selection process now ensures readiness and avoids bottlenecks.

Step-by-Step Guide to Software Readiness

Step 1: Assess Your Needs

Accountable Bodies should first evaluate what they need from a programme management system. Key questions to consider:

- Does the system allow for programmes to be quickly added and configured through a programme builder tool?
- Does the software support end-to-end case management?
- Can it handle complex workflows, such as eligibility checks, intervention tracking and reporting?
- · How quickly can it be deployed?
